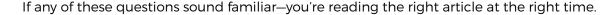

CHAPTER TREASURER: STEVE LENOIR



UPMA was the first Postal group PMG DeJoy spoke to after being sworn in as the nation's 75th Postmaster General and the last group on he addressed before resigning on March 28, 2025. We were privileged to have PMG DeJoy speak to our members on March 17, in Arlington, VA for 1 hour 20 minutes. As in previsions speeches he talked about changes made during his watch and how bad things were before he arrived.

He cut lose on the Postal Rate Commission (PRC) saying "The PRC needs to go. They have a first-grade education in what needs to be done and a doctorate in the unnecessary."

He also spoke about the Trump Administrations DOGE effort. Doge officials contacted him for a meeting, and he told them he was available for a half hour on Monday evening at 7:30 PM.

He gave examples of areas he shared with Doge on how the Postal Service can save money. The list included:

- USPS has 300 billion in CSRS Fund- we should be allowed to invest it.
- Workman's comp. program- we are spending 400 million a year.
- Unfunded congressional mandates- if we are required to maintain Universal Service congress should fund it.
- Counterfeit postage- we are losing 20 billion a year
- Post office lease renewals- "We are getting hijacked."
- 55% of post offices don't cover cost and 65% of routes are not profitable
- Leveraging our infrastructure- better use of our post offices and partnership with other Government agencies.

Before closing he said he was planning to stay for 3 years but stayed 4.5 years. "I came to love the place, as I leave, I'll be watching and will be a proponent for the Postal Service."

He told us he planned on staying through June to work with the new PMG. Eight days later he announced his immediate resignation. It makes you wonder what happened that week to change his mind about staying for another three months.

Our new PMG, David Steiner, former CEO of Waste Management, will assume office following the completion of background checks and the confirmation process. It remains to be seen whether he will proceed with the existing 10-year plan or introduce his own strategy. Only time will tell. For over 250 years, this beloved institution has a rich history of serving all Americans, regardless of economics standing. Intercity and rural areas that a private company will not touch. While we will have to adapt to changes in the marketplace, we are praying our new leadership will understand the "public service" mission of the postal service while also leveraging our business potential through our network of post offices and last mile reach.

This is my final article as an SC UPMA officer. After much reflection, I chose not to seek re-election as State Treasurer. The role of Treasurer carries significant responsibility. Managing chapter funds and ensuring transparency has been a privilege—and a duty I've taken seriously. I leave knowing that commitment has been honored.

Over the past four decades, I've been active in the League of Postmasters, NAPUS, and UPMA. These organizations have enriched my life in countless ways—through friendships, professional growth, and yes, even love (after all, it's where I met my wife, Beverly).

It's been an honor and privilege to serve on the UPMA board and Beverly and I look forward to remaining active in the future.

Career Development Benefit

- Networking UPMA offers networking opportunities from 3-digit meetings and Chapter Conventions to Area Conferences and National Conventions. This is a great avenue for contacts with subject matter experts (SME's) from all aspects of Postal operations.
- Training UPMA provides training in a variety of ways. Chapter and National Conventions offer workshops on current USPS programs and USPS Leaders provide information and answer questions. A national website - <u>unitedpma.org</u> - provides online training videos and national ZOOM training on current interest topics.
- eCareer Assistance UPMA has initiated a new national program to coach members on the development of an eProfile and eCareer for beginners and provide mentorship critiquing member's current eCareer's. The Career Development section on the National website provides the USPS Guidelines and UPMA Advice. An entry portal for member name, contact information and current job location will connect you with a Personal Assistant. Simply answer a few questions that allow determination of the level of assistance that is required. "Have you created an eProfile?" and "Have you applied for an EAS job?" will give us that information. You will receive a phone or email contact to discuss the next steps of either sending vour current eProfile and eCareer for review or how to begin the process of creating these documents.

Follow the Career Development path, on the back of this card, to the eCareer/KSA Assistance Program.

Follow these steps to the USPS Guidelines, UPMA Advice and the eCareer/KSA Assistance Program:

Go to Unitedpma.org; Career Development

There are two choices under this tab. In *Guidelines*, you will find 3 USPS documents with instructions on creating an eProfile, eCareer and submitting an application for promotion.

The UPMA Advice booklet is also located in this section. We suggest that you read it first as an overview of what the USPS specifically addresses. This information will allow you to set up your eProfile and be ready to work on your eCareer when you have decided on the type of EAS position you would like to apply for. The requirements for Supervisor positions or Postmaster positions may be similar for practicing your KSA's, but you MUST CHECK THE QUALIFICATIONS AND REQUIREMENTS FROM THE SPECIFIC JOB POSTING BEFORE APPLYING AS SOME DO VARY.

In KSA Assistance, you will find the portal to connect to a qualified Assistant who will coach, guide and mentor you through the eProfile and eCareer process. Integrity is a priority, so Assistants do not create or write your KSA's. They educate, suggest, encourage, and support your work until you have developed at a minimum, an eCareer that will provide you with the best opportunity to reach the interview level.

When you are ready to take advantage of this benefit enter your information in the portal (EIN, Name, Phone, Email, Current Job Position and State). Answer the questions about having an eProfile and having applied for an EAS position. A space for any comments is available. Here you may request a quick review, enter your work hours for contact availability or other beneficial comments. An Assistant will contact you to coach you through this accomplishment.

This is not an easy task. We recommend the *Situation, Task, Action, and Result (STAR) format*, which is not required but provides the easiest way to demonstrate your Knowledge, Skill, and Ability (KSAs) for a qualification. Rewrites are normal to make your STARS shine. UPMA provides the benefit of these Assistants for support and advice, as you invest in your career.
